Indeed human development report 1997, on poverty, defined it as deprivation in the valuable things that a person can do or be. The term human poverty was coined to distinguish dispread deprivation from the narrower income poverty, more conventional definition limited to deprivation in income or consumption.

Human development focus on expanding capabilities important for all people, capabilities so basic that there lack forecloses other choices. Human poverty focuses on the lack of these same capabilities-to live a long, healthy and creative life, to enjoy descend standard of living, dignity, self respect and the respect of others.

Economic and Social Rights

Health, education, housing and nutrition (a correlation between citizen and state) .In the study of human rights many studies has done yet and before also. These studies links between food nutrition, housing, sanitation, health care and education. For example good health reduces requirements for food and increases its effective use of nutrition. Higher educational attainment has a similar complementary effect on nutrition.

Civil Society and Freedom of Association

The Modi government continues to use the foreign contribution to use the foreign contribution regulation act (FCRA) which regulates foreign funding for civil society organizations, to cut off funds and stymie the activities of originations that question or criticize the government or its policies. In April 2016 Maina Kiai, The UN special reporter on freedom of assembly and association analyzed the FCRA and said that restriction imposed by the law and its rules "Are not in conformity with international law principle and standards".

In May the government temporally suspended the FCRA status of the lawyers collective an organization founded by Indira Jaising a former additional solicitor General on the right to health. In November the government refused to renew FCRA for 25 NGO'S including several prominent human rights groups.

Even as authorities were using FCRA to tighten restricted on NGO'S the government amended the law in March to retroactively legalize funding by foreign entities to political parties.

In spite of these international agreements the denial of women's basic human is persistent and widespread. For instance:

- Gender based violence kills and disables as many women between the ages of 15 and 44 as cancer. More often than not perpetrators go unpunished.

- Allowing free and independent media contributes to fulfillment of the fight to freedom of expression, thought and conscience.
- Separating powers among branches of government helps protect citizens from abuses of their civil and political rights.
- Encouraging an open civil society contributes to fulfillment the right to peaceful assembly and association. An open civil society adds an important participatory dimension, along with the separation of powers, for the promotion of rights.
